They were examined by us according to the

"Methoden zur Untersuchung von Papieren, Kartons und Pappen für Lebensmittelverpackungen", Stand 2008, entsprechend der Vorschrift Nr. 80.56 in der Amtlichen Sammlung von Untersuchungsverfahren nach § 64 des Lebensmittel- und Futtermittelgesetzbuchs - LFGB,

("Methods for testing papers and boards for food packaging", state of 2008, corresponding to the method no. 80.56 within the Official Collection of Test Methods according to § 64 of the Foodstuffs and Animal Feed Code - LFGB),

for the used raw materials, fabrication additives and special paper finishing agents as well as for the release of substances which might endanger health.

was carried out.

The paper grades are in compliance with the rules of the

Furthermore, they fulfil the demands of the

as well as those of the

Directive 2009/48/EC of the European Parliament and of the Council of 18 June 2009 on the safety of toys, Official Journal of the European Communities L 170/1 of 30 June 2009, last amendment by the Commission Directive (EU) 2020/2089 of 11 December 2020, Official Journal of the European Union L 423/58 of 11 December 2020, article 10,

for scraped-off toy materials regarding their chemical properties.

The requirements of the

Directive 94/62/EC of the European Parliament and of the Council of 20 December 1994, on packaging and packaging waste, Official Journal of the European Communities L 365/10 of 31 December 1994, last amendment by the Directive (EU) 2018/852 of the European Parliament and of the Council of 30 May 2018, Official Journal of the European Union L 150/141 of 14 June 2018,

regarding their heavy metal contents are also met by them.

Thus the paper grades **Offset Paper**, **DNS Performance +**, **Allround Envelope** and **Office Paper** each in various grammages, according to the sample material submitted may be used safely in the field of food packaging. They may stand in direct contact with dry and such fatty foods, for which a correction factor of at least 2 according to Annex III, Table 2 of the Regulation (EU) No. 10/2011 applies. Additionally, the respective papers in low grammages (up to 100 g/m<sup>2</sup>) may come into contact with fatty foods.

Moreover an application of the paper grades for toys is approved, as long as the toy is not intended for children under 36 months or intended to be placed in the mouth.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
